## 1. PRICING, SERVICE SELECTION & COMMISSION

- **Initial Listing Price:** Items will be listed at approximately 30% below current estimated retail value.
- **Markdown Schedule:** If the item does not sell within 60 days, the Shop reserves the right to reduce the price by an additional 15%.
- **Payout:** Payments are issued via E-Transfer on the 15th of each month. Any balances less than \$50 will be held over.

Please **select** one service level for the items in this agreement:

- **TIER 1: IN-STORE (50/50 Split)** – Drop off your smaller items and we handle the storage, display, and sales while you wait for your payout.
- **TIER 2: VIRTUAL (60% payout)** – Our highest payout: keep your items at home until they sell and get a bigger cut of the profit for providing your own storage and clear photos for our website. Items must be dropped off at the store within **24 hours of a confirmed sale**
- **TIER 3: FULL SERVICE (30% payout)** – The 'hands-off' experience: we come to you for photos and handle the pickup once it sells.

## 2. CONDITION & LIABILITY

- **Completeness:** All items MUST include all necessary mounting brackets and hardware.
- **Photo Accuracy:** For virtual listings, Consignor warrants that photos accurately represent the item. If a buyer rejects an item due to undisclosed damage, the sale is voided.
- **Liability:** Items are consigned at the Consignor's risk. The Shop is not responsible for loss/damage due to fire or theft. For Shop Pickups (Tier 3), the Consignor holds the Shop harmless for incidental property damage during removal.

**3. THE 90-DAY RULE & EXPIRATION** Items are listed for a maximum of 90 days. If an item remains unsold, the Consignor must **select** one of the following (please initial):

- \_\_\_\_\_ **OPTION A (Pick-up):** The Consignor must retrieve the item within 5 business days of notification.
- \_\_\_\_\_ **OPTION B (Disposal):** The Shop will dispose of or recycle the item at the Shop's discretion.
- \_\_\_\_\_ **(Initial)** *Items not retrieved within 7 days of the expiration date will be deemed abandoned. Ownership of abandoned items **immediately reverts to Reno Resources**, to be sold, donated, or disposed of at the Shop's sole discretion.*
